UK men's basketball roster payroll to exceed \$20 million

LEXINGTON, Ky. (KT) — Kentucky's men's basketball payroll reportedly exceeds \$20 million, according to a report released by the Lexington Herald-Leader on Thursday.

The figure, estimated to be at \$22 million, exceeds the number spent last season and the \$4 million former coach John Calipari used to build his last squad as coach of the Wildcats.

Coach Mark Pope joked recently that the program's payroll was "close to \$200 million."

"We would like to win at everything,

No regions are classified as severe drought (D2) or higher.

National Weather Service meteorologist Richard Tinker said heavy rain—up to eight inches in some parts of the Ohio Valley—helped bring major improve-



The Lady Bombers earned the number 1 seed and automatic berth into the 1st Region Tournament by winning the regular season title. Graves squeaked out a 3-set sweep over Mayfield to advance to the title match. The Lady Eagles picked

up where they left off against the Lady Cardinals running out to an 8-2 lead. **Ballard Memorial** chipped away at the lead and gained a 21-20 advantage. Following a Graves timeout, the Lady Eagles outscored the Lady Bombers 5-2 to close the set with a 2 point win. Graves was aided by 2 Ballard Memorial serve errors to close the set and the Lady Bombers committed 6 serve errors in the opening set. Ballard Memorial gained a

10-5 lead in the 2nd set before Graves called a time out. Once again, the Lady Eagles responded after the time out, scoring 8 in a row. Ballard Memorial went on an 8-2 run late to gain a 25-24 lead and served for the set win. Another serve error proved costly as **Graves County scored** the next 2 points following the error to win the set. The Lady Eagles went out to a 19-7 lead in the 3rd set and cruised to a 3rd set win and a 3rd



LOUISVILLE, Ky. (KT) - Louisville basketball coach Pat Kelsey undertook an unorthodox route to land his first class of 2026 commitment in 6-foot-3 guard London Johnson, who has spent three seasons in

the NBA G League. Johnson, 21, announced his pledge on Monday in a post to X. The former 4-Star from Norcross, Ga. was originally a member of the 2023 class, but he reclassified, then turned pro in October 2022. He is expected

to join the program in December, sit out the remainder of the 2025-26 season, then have two years of eligibility remaining.

He's got a chance to be really special in a list of bigs that have been incredible here at Kentucky." Moreno doesn't


mind the rebounding aspect of the game and has developed a reputation as one of the top rebounders on this year's squad. "I like the

Murray State's nurse anesthesia graduates achieve 100% board exam pass rate

MURRAY, Ky. (KT) – Murray State University says their Nurse Anesthesia Program recently achieved a 94 percent first-time pass rate on board exams, with a 100 percent overall pass rate.

The Class of 2025 was composed of 16 nurse anesthesia students who successfully completed the program in August.

"Our students have a baccalaureate or graduate degree in nursing and at least one year of work experience as a Registered Nurse in a critical care setting, prior to admission to the Doctor of Nursing Practice (DNP) program," said Murray State's Nurse Anesthesia Program Administrator Dr. Tiffany Eye. "Upon completion of the DNP program, nurse anesthesia students must pass the National Certification Exam to become a Certified Registered Nurse Anesthetist (CRNA)."

CRNAs deliver safe, high quality anesthesia care and practice in every setting where anesthesia is delivered: hospital and ambu-

latory surgical centers; obstetrical delivery settings; the offices of dentists, podiatrists, ophthalmologists, plastic surgeons and pain management specialists; and all branches of the U.S. military and Department of Veterans Affairs healthcare facilities. CRNAs represent more than 80% of the anesthesia providers in rural counties. Half of U.S. rural hospitals rely on a CRNA-only model, utilizing independently practicing

CRNAs to safely deliver surgical and obstetric services to their communities.

Many of Murray State's CRNA graduates remain in the region to practice. Eye said of the last three cohorts to graduate, 68 percent have remained in Kentucky to practice.

She credits the success of the program to excellent faculty, determined students and supportive University leadership.

"Murray State University's
Nurse Anesthesia Program offers
a culture of excellence with didactic coursework and clinical rotations that prepare students to
provide exceptional care to patients and families throughout the
Commonwealth and nation," Eye
noted.

"The rigorous curriculum emphasizes critical thinking, clinical expertise, professional development and board preparedness. Faculty maintain active nurse anesthesia practices, providing expert, relevant instruction and student mentorship. The program's state-of-the-art simulation training and robust clinical rotations broaden a graduate's skillset and prepares them for diverse practice settings."

The Kentucky Program of Anesthesia was officially opened in 1992, with the first class of six students entering the program in August of that year, according to Eye. Since then, the program has continued to grow, admitting 26 students this past summer for the Class of 2028.

Paducah Commission boosts Remote Worker Incentive, updates Health Plan

PADUCAH, KY — The Paducah Board of Commissioners approved updates to the city's Remote Worker Incentive Program, first launched in 2021.

To date, the program has brought 26 new residents to Paducah.

Under the new ordinance, self-employed remote workers are now eligible — a group that previously accounted for nearly 19% of applicants but couldn't participate.

The incentive structure also changes from reimbursements to direct cash payments totaling \$5,000, paid in two \$2,500 installments:

First payment: Upon establishing residency in Paducah

Second payment: On the one-year anniversary of relocation



KDA awards three Kentucky school districts for purchasing Kentucky food products

FRANKFORT, Ky. – This October, National Farm to School Month, three Kentucky school systems are being awarded for their dedication to purchasing and using locally grown produce and proteins.

The schools are being awarded through the Kentucky Department of Agriculture's (KDA) new Kentucky Farm to School Stars Recognition Program, which was created to recognize school districts that demonstrate a commitment to increase purchases directly from Kentucky farmers.

"Kentucky farmers produce some of the most nutritious and delicious food in the world," Kentucky Agriculture Commissioner Jonathan Shell said. "Developing programs and incentives to get more

of that food into our Kentucky school meals increases the nutrient level for our school children and positively impacts our farm families."

The school districts recognized in the program's first year and the amount awarded are:

- Jackson Independent Schools in Breathitt County-\$10,000,
- Mercer County Public Schools -

\$8,000.

• Barren County Public Schools -\$6,000.

Winning districts had the highest percentage of locally produced proteins and produce for an entire school year in their meals. Eligible districts also had to participate in the National School Lunch Program. Only Kentucky grown or raised products used during breakfast and lunch during the

regular school year were eligible, excluding milk.

The monetary awards each district received must be spent on local food purchases for the 2025-26 school year.

The winning funds were awarded through KDA's portion of the Ag Tag funds, which come from the voluntary donations Kentuckians pay each year when renewing their

farm license plate. The donations are divided equally among Kentucky 4-H, Kentucky FFA, and KDA. This year, donations reached a record high of \$995,440.74.

"KDA makes a promise to reinvest its share of the funds into our agriculture community," Commissioner Shell said. "This year we are keeping that promise by investing into our youngest generation – our children."

FEMA has provided \$106 million to **Kentucky disaster survivors in 2025**

FRANKFORT, Ky. (KT) - The Federal Emergency Management Agency (FEMA) says they have now distributed more than \$106 million to survivors of the three federally declared natural disasters in Kentucky this year.

As of Oct. 20, FEMA has paid out \$67.9 million for losses suffered in February's severe weather, \$34.9 million for April's severe weather and record flooding, and \$3.7 million due to damage from May's tornadoes. While the deadline for apply for benefits in all three disasters has passed, FEMA continues to process applications and issue payments daily.

Kentucky Emergency Management (KYEM),

along with FEMA Individual Assistance Specialists in Kentucky are continuing to answer survivors' calls at the state's Unmet Needs Call Center, which is (502) 607-6665.

Kentucky survivors who have already applied for federal assistance may call experienced agents at that number to request a case review, make an appointment to meet in person, check the status of appeals or confirm processing decisions, confirm whether submitted documents have been received, get answers to questions about information or documents needed to resolve ineligibility determinations, get clarification on correspondence from FEMA after a missed call or

text, or get additional support for more complex issues.

If you applied for FEMA assistance and you're receiving phone calls and text messages from a number you don't recognize, it could be a FEMA representative trying to get in touch with you. The representative may need to schedule an inspection or get more information to process your application. FEMA says to please return the calls, otherwise, your application may be stalled.

Continued Temporary Housing Assistance is available for survivors who cannot live in their homes because of the flooding, storms, and tornadoes that occurred in Kentucky. Survivors who received two months of rent money from FEMA may also be eligible for Continued Temporary Housing Assistance.

If you remain in need of temporary housing, contact the FEMA Helpline at 800-621-3362 for more information.

If you applied for FEMA assistance, then you should have received a letter from FEMA. The letter is sent via email or mail, and explains your application status and how to respond. It is important to read the letter carefully because it includes the amount of assistance you are eligible to receive and how it can be used. It also explains what you may still need to do (such as completing an inspection, providing certain documents etc.) to receive FEMA money.

The Brinnon Fire Department in Washington State reported that a lady in her 40s requested emergency assistance, after falling headfirst into a vault toilet at a frequented hiking area. On the list of "worst things to happen to hikers," this ranks as number two. How did she end up neck-deep?

She reportedly dropped her smartphone in the outhouse latrine and attempted to retrieve it—unsuccessfully. Initially, she tried fishing it out with her dog's leash, and let's just say her furry friend went home leashless that day. Next, she removed the seat and leaned into the abhorrent abyss to get closer—and that's when it happened. The entire latrine collapsed inward, causing her to plunge into the filth below, where she dialed 9-1-1 from her soiled cellphone. All of this for a \$200 smartphone.

The lengths we will go for what we love and the things we are willing to do for what we value are truly astonishing. And many times, the price we pay in doing so is not worth the gain. But this is precisely what we do when worshiping gods that are not God. We often invest precious time, money, and energy into idols we believe will make us happier and more fulfilledalthough they leave us down in the dumps. As the psalmist counseled, "The sorrows of those who run after another

god shall multiply" (Psalm 16:4a).

Idol-worship always costs more than it pays, and the false gods of possessions, protection, power, pleasure, prestige, and position always take more than they give. As Jonah cautioned, "Those who pay regard to vain idols forsake their hope of steadfast love" (Jonah 2:8). You can't get from gods what you can only get from God. So, why give to gods and get nothing when you can give to God and get everything He promises?

Nevertheless, emulating Josiah of old (2 Chron. 34:33) and demolishing our idols is challenging because, as John Calvin once stated, our hearts are "factories of idols," equipped with a golden-calf assembly line, eager to fashion a god from anything and everything. Paul likewise stated in Romans that we are prone to worship and serve "the creature rather than the Creator" (Rom. 1:25). This is why we are exhorted, "Flee from idolatry" (1 Cor. 10:14, KJV), and admonished, "Little children, keep

yourselves from idols" (1 John 5:21). Therefore, we must continually "turn from these vain things to a living God, who made the heaven and the earth and the sea and all that is in them" (Acts 14:15b).

Idols are all glitter and no gold—God is God and always good. Idol-worship stinks—worshiping God satisfies. As David declared: "You make known to me the path of life; in your presence there is fullness of joy; at your right hand are pleasures forevermore" (Psalm 16:11).

The basics of breast cancer

Breast cancer is a formidable disease that affects millions of individuals each year. Data fromm the World Health Organization indicates 2.3 million women were diagnosed with breast cancer in 2022, when it was the most common form of the disease in 157 of 185 countries across the globe.

The impact of breast cancer goes beyond those diagnosed with the disease, affecting friends, family members, professional colleagues, and others as well. That far-reaching impact means everyone has a vested interest in learning about breast cancer.

What is breast cancer?

The Centers for Disease Control and Prevention notes breast cancer occurs when cells in the breast grow out of control. The breast is made up of three main parts known as the lobules, ducts and connective tissue, and which type of breast cancer a person has depends on which cells in the breast turn into cancer.

Is there a typical breast cancer?

No two individuals diagnosed with breast cancer will have the same experience after being diagnosed. However, the CDC notes that most breast cancers begin in the ducts or lobules. The ducts are tubes that carry milk to the nipple and the lobules are the glands that produce milk.

What are some common risk factors for breast cancer?

The National Breast Cancer Foundation, Inc. notes gender is the foremost risk factor for breast cancer, as the WHO reports that 99 percent of breast cancers occur in women. Additional



risk factors for breast cancer include age, with two out of three women diagnosed with invasive breast cancer being older than 55, and race, as the disease affects more Caucasian women than women of other races. The NBCF also notes that women

who have dense breast tissue may be at greater risk for breast cancer because such tissue can make it harder to detect lumps.

What causes breast cancer?

The NBCF notes that most women who

have breast cancer will never be able to identify an exact cause behind their disease. Common risk factors like gender and age are beyond women's control, but there are some controllable risk factors that can be avoided. The WHO notes that


overconsumption of alcohol and tobacco use are two such factors.

How important is early detection?

The American Cancer Society reports that the five-year survival rate for breast cancers discovered in the localized stage is 99 percent. That underscores the significance of early detection. The NBCF notes monthly breast self-exams and routine clinical exams increase the likelihood of early detection. Women are urged to speak with their physicians regarding how frequently they should be tested, as recommendations vary depending on each individual and their respective family histories.

The basics of breast cancer provide insight into the disease and what women can do to reduce their risk of developing it.







Needing answers? Prayer is a spiritual law

much better to have a house located a block away from the ocean, built on a firm, solid foundation. Our preference is not what counts. The Bible says, "Obedience is better than sacrifice" (I Samuel 15:22). When storms come, we need a solid foundation in God's word and His promises.

If lack of obedience was the problem, how could Cain have solved it? (The same way we have to). We just have to cooperate with God. "To him that knows to do good, and doesn't do it; to him it is sin (James 4:17). The easy way is not God's way

Seeking comfort and not being willing to stand against sin leaves us lukewarm and vulnerable to defeat and destruction. Christians who avoid getting their hands dirty with prayer and obedience might have religious knowledge, but are developing spiritual muscle atrophy. If we stay on the couch and only eat rich foods and dream of pleasures, before long, we will not be strong enough to take care of ourselves. This is what happens in the spirit realm when the only outward sign of being a Christian is talking "about" God. Many do not read or study the Bible on their own and just remember what someone else has said. Why? Because they are lazy and have anxiety that the Lord is going to demand them to give up everything they have and follow Him. Matthew, Mark, and Luke tell the story of a rich young ruler who spoke to Jesus about how he could obtain eternal life. It's common to feel pity when we only see this as a selfish,

arrogant person who would rather remain in control of their own life. However, it becomes sobering when we realize this is also a direct demand to all who call themselves disciples of Christ.

There was a time King David grew weary of his struggles. He was so tired in his soul, so embattled and beset by troubles, all he wanted was to escape to a place of rest and comfort. In Psalm 55:4-8 we read, "My heart is sore pained within me: and the terrors of death are fallen upon me... And I said, Oh that I had wings like a dove! For then would I fly away, and be at rest... I would hasten my escape from the windy storm and tempest." There is a valuable lesson to be learned when we substitute our responsibility to obey God with an easier, more relaxing, and pleasurable way. If you read about crabs, they are creatures that live in a rough, dangerous environment among jagged rocks. Crabs are constantly pummeled by the waves and attacked on every side by creatures from

deeper waters. Their lives are a continual battle to protect themselves, but over time, they develop an endurance, a strong shell, and powerful instincts for survival. However, some give up the struggle and search for a more complacent way to live by taking up residence in the abandoned shells of other ocean dwellers. These crabs are known as hermit crabs. They escape the hard work to relax in comfort.

However, when the crabs become inactive and stop fighting the good fight, atrophy sets in, and their bodies deteriorate. Even their organs wither due to lack of use, and eventually they lose all power of motion, as well as the ability to defend themselves from their enemies. As their claws fall off, they are left with a powerless existence. Likewise, going through the motions of a nominal and mediocre religious existence is not what God wants. When the Christian surrenders to the temptation to live in carnality, they no longer care about being a living sacrifice. Yes, the battle is hard, and it's much easier to hide in the shell of religion than to actually do what God is demanding. Read Matthew 24:13-15.

Ephesians chapter six talks about the seven types of armor that Christians have been commanded to wear in this life, as God has called us to be fearless warriors in the battle against evil. We have the helmet, breastplate, shield, sword, boots, the belt, and the most important weapon – prayer. When a soldier engages the adversary, they are protected from the

front, but there is no mention of protection from the back. The call to war is to stand firm against the enemy, as this allows faith and power in God's name to boldly confront the darkness face to face. The saint must not turn and run away in fear, as this exposes their back, and they become a vulnerable target to be easily brought down with deadly arrows and spears. It would be better to remain in prayer and continue developing wisdom, discernment, and faith than to participate in spiritual warfare unprepared. Remember the true account in Mathew 17:19-21. Awaken, and take your place on the front lines today! The devil tries to persuade us to take it easy, but remember, his mission is to steal, kill, and destroy. As a liar and deceiver, he appears to be friendly and tries to persuade us with compromises, but is holding a dagger behind his back.

Funds reallocated for Senior Meals program

FRANKFORT, Ky. (KT) - Gov.Andy Beshear announced Monday his administration has reallocated \$9.1 million to the Aging and Independent Living appropriation for the Senior Meals program, following news that Area Development Districts (ADDs) have exhausted all previously budgeted funding for the program.

He also said the state will support the federal Temporary Assistance for Needy Families program, or TANF, through the month of November as the federal shutdown reaches the 20-day mark, and that the state faces a more than \$300 million budget shortfall during the current fiscal year, which ends June 30, 2026.

"No Kentuckian should ever face hunger, which is why my administration has directed more dollars toward funding senior meals than any other administration in the Commonwealth's history," Beshear said during a media briefing. "While I am glad that we have found a temporary solution, our state faces real challenges with the potential \$305 million budget shortfall, the exhaustion of onetime federal ARPA funds and additional expenses the state faces due to the federal shutdown We must remain fiscally responsible and work within a budget to provide the support and services Kentuckians need."

Shortly before the briefing, Beshear says he held a call with ADD leaders from across the state to share the news. During that call, the governor says he also shared plans to request that the Finance Cabinet review the entire Senior Meals program to understand future funding needs and ensure consistent practices across the program.

"Just like our Kentucky families, our state must work within a balanced budget," Beshear said. "To ensure we remain fiscally responsible while still appropriately funding the Senior Meals program, we must understand the difference in costs per meal across the different ADDs, as well as eligibility, procedures and numbers of meals available to confirm all funding is being used appropriately."

He told reporters he has requested the General Assembly retroactively approve the movement of the \$9.1 million, which leadership has agreed to do.

Sen. Greg Elkins, R-Winchester and co-chair of the Legislative Oversight and Investigations Committee (LOIC), commended the state budget director's decision to transfer funding Friday.

"This action is long overdue, but it finally delivers what the legislature has been asking for since the Beshear administration's abrupt September 8 memo left local agencies and seniors confused," Elkins said. "For more than a month, the governor offered no plan to remedy this problem, and only after continued pressure from

lawmakers has the administration finally identified one.

"From the start, my colleagues and I made it clear that the executive branch already had the authority and the flexibility to move existing funds to meet this need," he said. "We stood ready to correct the mistake ourselves if called into a special session. It shouldn't have taken public outcry for the administration to act. Now that funding will be released, the focus must be on getting meals delivered quickly and rebuilding trust with those who administer

this critical program and the elderly Kentuckians who rely on it."

The ongoing federal shutdown is also impacting SNAP, which more than 600,000 Kentuckians rely on, he noted. Due to the shutdown, the U.S. Department of Agriculture (USDA) has prohibited funding in November for SNAP benefits.

The governor noted, SNAP recipients

can continue using current benefits as normal. For updates, Kentuckians can visit the Department for Community Based Services (DCBS) website or their Self-Service Portal (SSP) account.
