National Farm Show returns to Louisville for 60th year

LOUISVILLE -- “Every year is an important year for the National Farm Machinery Show as we bring the best in the field together,” said David S. Beck, President and CEO of Kentucky Venues. “Reaching a milestone like the 60th anniversary is a powerful reminder of the show’s legacy and a chance to honor the generations of farmers, innovators, and partners who helped build the show, while continuing to look ahead at what’s next for the future of agriculture.”

Over the four days, an international crowd will browse sold-out exhibit halls showcasing brands such as AGCO, Case IH, John Deere, Massey Ferguson, and New Holland. In addition to expansive equipment displays, attendees can take advantage of free daily educational seminars led by industry experts offering in-

sight into the best farming and production practices. Visitors can also shop from nearly 50 retail vendors at the Gift & Craft Market selling clothes, keepsakes, souvenirs, and more.

In tandem with the farm show, the 57th Championship Tractor Pull sponsored by Farm Credit Mid-America returns to Freedom Hall for five dirt-slinging sessions. Now featuring new seats in the lower sections, the event runs nightly at 7 p.m. Wednesday through Saturday, with an additional noon session on Saturday. Around 200 drivers from across the United States and Canada will compete during the high-octane, heart-pounding sessions. Tickets can be purchased online via Ticketmaster and at the on-site Ticket Office. Livestream and archival footage are available at stream.champullorg.

The National Farm Machinery Show is free and open to the public.

Seeing life through two pairs of eyes

I’m really bad about obsessing over the wrong things. I like schedules and structure. So, when things happen that upset my structure that’s not a real comfortable place for me. Although my comfort zone is structure, as all of us know, that’s not the norm because in this life something always changes. And, out of necessity, I adapt.

I know a lot of Martha’s (not the name, but the thought process), and sometimes I see myself as a Martha. She obsessed over serving her guest while her sister, Mary, sit comfortably at Jesus feet, worshiping and listening.

In the Mary/Martha story, Jesus came to have dinner at Mary

and Martha’s house. It didn’t transpire like Martha had planned and she was upset. (Luke 10:38-42). Jesus told Martha that Mary, her sister, had chosen wisely to not obsess over serving the guest. Believe me, I try to learn from Jesus’ concept about not obsessing over the wrong thing. I try, but sometimes I still obsess over things that matter too much to me and not to anyone else.

When we stop obsessing over serving, we realize some things are just not worth obsessing over. At the time it seems very important, but in the scheme of things, it isn’t. Jesus knew this. Knowing how I am, I can’t help but appreciate the fact that He made this a big deal in the Martha/Mary story. As the story goes, Mary had a heart full of love and worship for



Jesus and she didn’t let things around her take away from that.

Martha, on the other hand, loved and worshiped Jesus just as much as Mary, but her heart was also focused on what she had to get done. Martha was the sister who was obsessed

with what her guest thought about her. In her heart and mind, I know she thought it was important to focus on pleasing Jesus and making him feel comfortable in her home. I believe she thought she was doing a good thing. The sisters just saw life

through two different pair of eyes. Remember it was Martha who fully trusted Jesus’ love after Lazarus died! (John 11:20-28).

In the story, obviously, Mary saw the invisible while Martha focused on all the things that needed to be taken care at the

moment. Both sisters were doing their best to make an impact on Jesus and their other guest. And, both were doing important things. We need Mary’s and we need Martha’s. But most of all, whenever and wherever we find ourselves, remembering to stress a little less and relax a little more might be the key to all the chaos in the world

I am reminded of 1 Timothy 6:11, “... Follow after righteousness, godliness, faith, love, patience, meekness.” We can care too much about what people think of us and not enough of what God thinks. God wants balance in our lives so we love, serve and respect both Him and other people. Could finding balance in our focus be the theme of the Mary/Martha story?

Believer’s baptism or baptismal regeneration?

Believer’s baptism and baptismal regeneration represent two distinct views on the role of water baptism in salvation. Believer’s baptism holds that baptism is an outward, symbolic act of obedience performed “after” a person has consciously trusted in Jesus Christ and His blood for salvation. Conversely, baptismal regeneration teaches that baptism is the sacramental law where God creates spiritual rebirth, forgives sins, and initiates spiritual regeneration. While I tend to avoid writing about church doctrines due to disagreements, my ministry requires me to share my personal interpretations. I’m often asked about what washes away our sins, the water or the blood? There is power in His blood – not the water.

I share the gospel often, including in our local Detention Center on a regular basis. A place to teach and baptize is provided, and our team also serves communion to the new converts. This gives us an open opportunity to explain what it means to confess receiving Jesus as Lord and Savior. Sadly, not all Christians are united with church doctrines such as immersion versus sprinkling, infant baptism, and baptizing in the name of Jesus versus in the name of the Father, Son, and Holy Spirit, but even more importantly, there are different opinions about what exactly happens when the person goes under the water.

Some churches, including Roman Catholic, Eastern Orthodox, Lutheran, Churches of Christ, and some Anglican and Episcopal churches, including the Mormons, and

Jehovah’s Witnesses, believe in what is called baptismal regeneration, which means a person is not cleansed from sin or spiritually transformed into a new creation in Christ until after they are baptized. Within these churches, baptism is referred to as a requirement that defines water as the only way to literally receive God’s grace, which saves. Groups such as Baptist, Church of God, Assembly of God, Reformed Presbyterian, Non-Denominational, Evangelical, Anabaptists, Mennonites, Quakers, Puritans, and The Salvation Army, use the term “ordinance” meaning that baptism although an important act of obedience, is only a public testimony symbolizing God’s power that has already forgiven and transformed the spirit’s of those who

called upon the name of the Lord to save them, according to John 3:16.

As we are immersed under the water, this displays the spiritual reality of how we died to ourselves, were buried with Christ, and in coming up out of the water, we are raised from the dead by the glorious power of God to walk holy and obey Him in everything as His child. An outward sign of an inward work. Since we have been united with him in his death, we are also raised to life as He was. Yes, we are forgiven and washed clean by the blood of Jesus, as the power of sin is broken, and our carnality was crucified with Christ. As no longer slaves to sin, the new Christian is declared righteous through Jesus, but still has the free will responsibility to demonstrate His holy nature and character. We should consider ourselves

to be dead to the control of sin and to have faith in God for everything. Take a moment to read Romans chapter 6. In fact, as we develop a solemn, reverential fear and awareness of His presence, sin should literally make us nauseated as we realize how much our disobedience hurts Him. If our intentional sins do not cause brokenness, weeping, and deep sorrow, we have become spiritually numb, calloused, and deceived. However, with God’s grace and mercy, our spiritual determination to deny our flesh and walk in sanctification can be rekindled by returning to our first love.

Baptism is not just a religious ritual. It’s a deeply personal commitment to living the life this holy re-enactment is revealing. It represents death to sin, the burial of our old life, and the

resurrection to a new life in Christ! We are confessing and professing that Jesus is our Lord, and the miracle of being born again. We receive the gift of God’s love by declaring to the world that we are completely dedicated to loving and serving our Master. The believer’s baptism is an open display and promise that we will fulfill our vow to never return to who we once were. We now promise to allow God to lead us, we have become a temple of the Holy Spirit and are filled with the marvelous light of His eternal truth. Jesus died and resurrected so that you could become a member of His everlasting kingdom of peace and joy. Will you respond to His voice today?

When Heaven quakes

A traumatic earthquake in San Francisco deeply devastated the little boy, although he was oblivious to it. But he showed subtle signs of how shaken he was on the school’s swingset. The lad’s teachers observed that he would run for the swings during recess, and sway back and forth until it was time for school to resume. And when a teacher finally asked him why he bypassed the slides

and merry go-round to swing alone, he sadly answered, “On the swing, I move like the earth. So, if there’s another earthquake, I won’t feel it.”

Without realizing it, he diagnosed the knee-jerk reaction we often have when we endure troubles in our lives. When we go through a life-shaking storm—an earthquake-level tribulation that rattles our world—we tend to brace ourselves for the next one. We live anxiously and guarded, worried that if things start to get better, that can

only mean they are about to get worse. We often find ourselves quaking before the ground does.

But the heartening truth of Scripture is that a much greater “quaking” takes place in heaven when we pray during times of trouble. As David said in Psalm 18, “In my distress I called upon the LORD; to my God I cried for help . . . Then the earth reeled and rocked; the foundations also of the mountains trembled and quaked, because he was angry. The LORD

also thundered in the heavens, and the Most High uttered his voice, hailstones and coals of fire. He sent from on high, he took me; he drew me out of many waters” (Ps. 18:6a, 7, 13, 16; cf. Acts 4:31; James 5:16b).

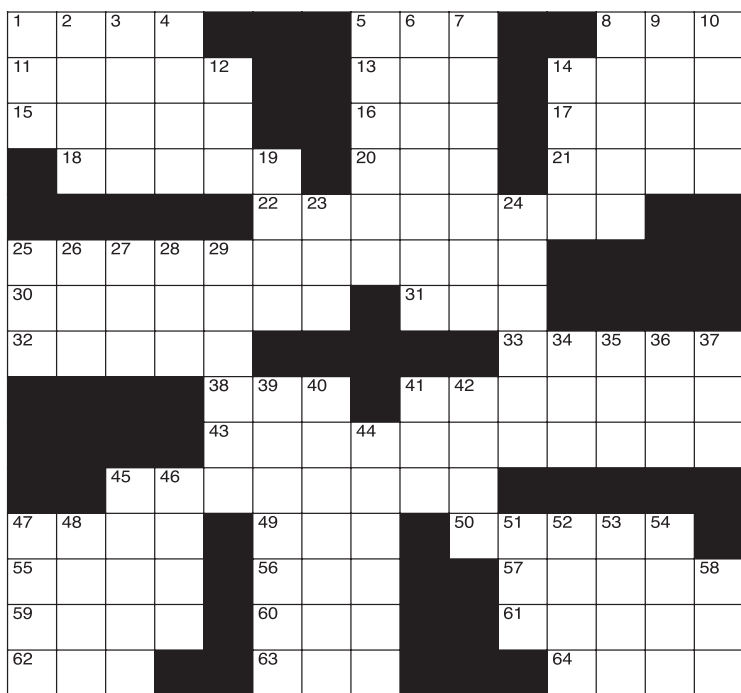
When we send up a prayer for help during trials, the Lord treats it like a call for backup. At the sound of our requests, God rises like a mighty warrior from His throne, rattling the floor of heaven with His swift steps, and heaven’s gates fling open wide just so the

Lord can get to our side. When we pray in peril, God shouts across the heavens as though to say, “Out of My way, My child is in trouble!” When our prayers reach His ears, He leaves the throne-room of glory and enters the battlefield with us. He conducts a search-and-rescue mission when we petition Him for mercy in misery, and will even mobilize creation itself to provide us with reinforcements so we can survive the battle.

Every good father—upon hearing his

child crying in danger—would drop everything, rush to his location, and push aside anything that stands in his way. Likewise, our heavenly Father rushes to our position, pushing aside all the glories of heaven and all the starry hosts of the heavens to come to our aid when we need Him. As James Rowe (1865-1933) wrote in the great hymn Love Lifted Me, “But the Master of the sea heard my despairing cry, from the waters lifted me—now safe am I.”

Crossword Puzzle

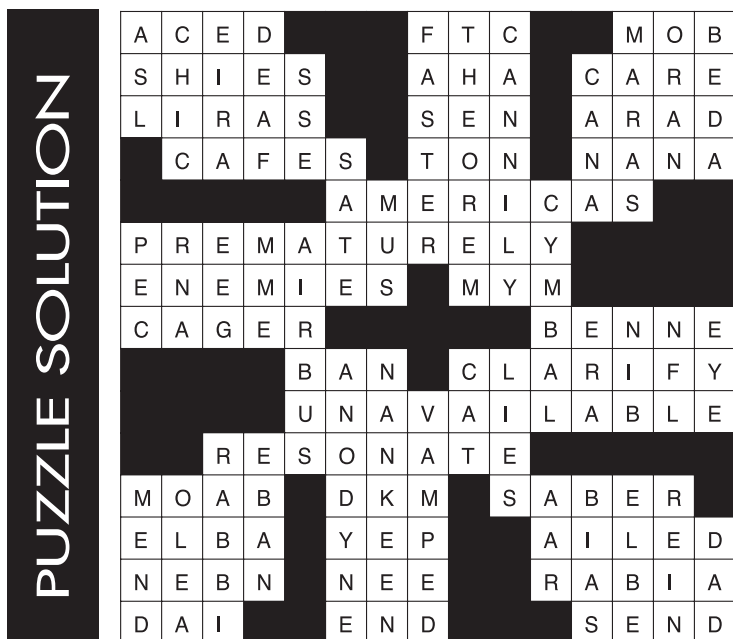

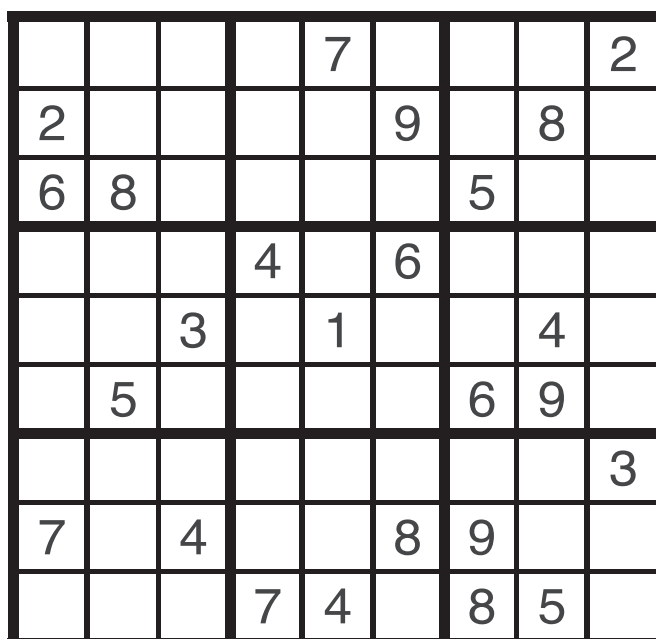

How it Works:

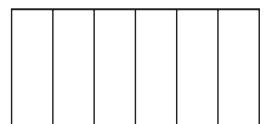

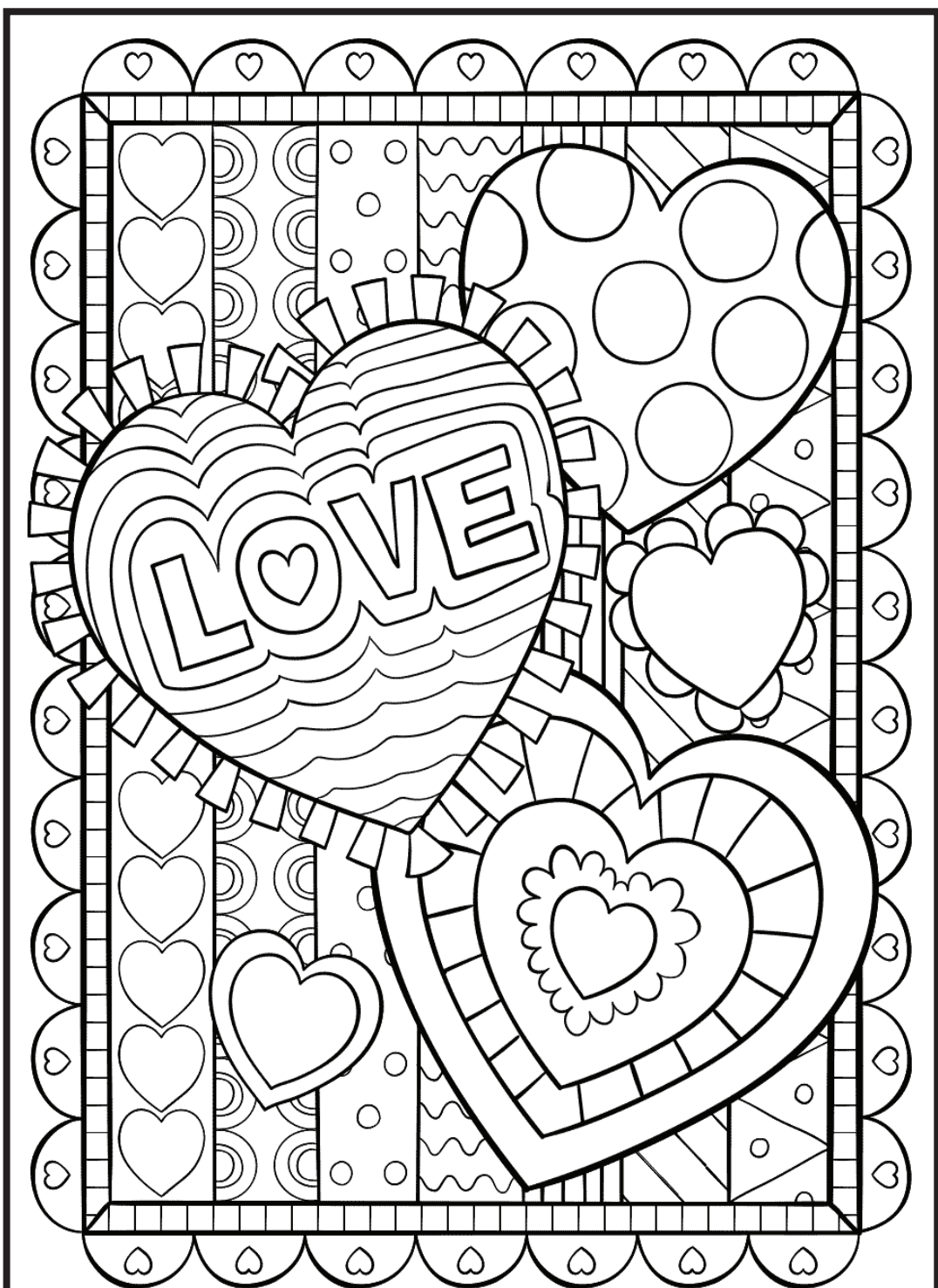

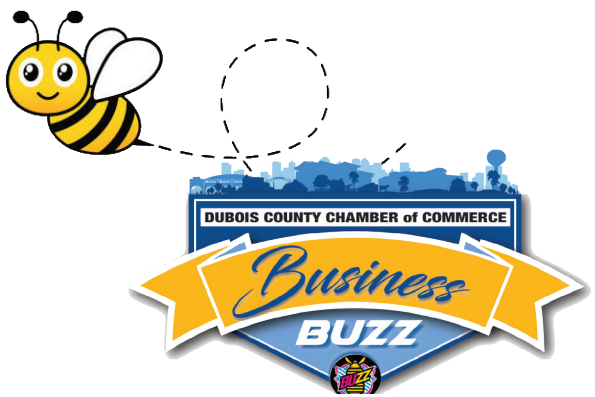

LETTER TO THE EDITOR

Traffic problems on Hwy 231

For all of us who drive on Hwy 231, it is clear that we have a traffic problem with the large number of semi tractor trailers and the increasing daily vehicle traffic. This traffic issue can be resolved with the construction of the Corridor.

The Corridor is for all of the citizens of Dubois County. Perhaps, most importantly, the Corridor will provide substantial time savings for not only those of us who are driving within Dubois County, but also for the many people who are coming to Dubois County to work and shop and those of us who are trying to reach our destinations outside of the County. All of us have experienced wasted time stuck in long lines

of traffic. Time which would have been better spent with our families or at our jobs. Yes, the time savings may range from one minute to fifteen minutes per trip, but think of the number of trips you make to your job each week, each month, each year. The Corridor could give back to you days and weeks of time that could be better spent with your family and not stuck in your car frustrated by traffic congestion.

The Corridor also will mean better safety for all of us driving on Hwy 231. First the Corridor will remove up to 80% of the heavy truck traffic off of current Hwy 231 and onto the Corridor. That fact alone is extremely important to all of us and our families

who want to be able to drive safely on Hwy 231. Additionally, for those drivers who will use the Corridor on a daily basis to get to our jobs or get to other locations outside of Dubois County, a divided four-lane road generally reduces traffic accidents by fifty percent over a two-lane roadway.

Finally, although it has not been significantly raised as an issue, the thousands of cars, trucks, and semis that are idling in the middle of our communities are impacting the health of our communities. It has been identified that as much as 50% of the vehicle traffic on Hwy 231 could be relocated to the Corridor after it is built. The ability to have

up to 10,000 vehicles relocated outside of our communities will also have a significant beneficial health impact to our communities and all of us as citizens.

I wanted to make sure that the positive impacts of the Corridor are also made clear to all of us as citizens of Dubois County. Lastly, I sympathize with the landowners who will be sacrificing some part of their land for the construction of the Corridor, but there is not a road that we drive on today that did not require some prior landowner to make the same sacrifice... for the good of our community and the future of our children and grandchildren.
